Wastewater Collection System Improvements Project in Ímuris, Sonora.

The local water utility, *Organismo Operador Municipal de Agua Potable, Alcantarillado y Saneamiento de Ímuris* (OOMAPAS or the Executing Agency) has received a grant from the North American Development Bank (NADBank), through its Community Assistance Program (CAP), as executed through CAP Agreement **SN1097**, to finance part of the costs associated with the **Wastewater Collection System Improvements Project in Ímuris, Sonora, Mexico** (the "Project").

OOMAPAS-Ímuris intends to contract a consulting firm to provide the following services:

Management, coordination and supervision services for construction of the wastewater collection system improvements in Ímuris, Sonora.

Bidding for contracts financed by NADBank is open to firms from any country. Because the funding for this project is administered by NADBank, the bidding process will be carried out in accordance with its procurement policies and procedures. Companies that have been previously penalized by NADBank and/or had contracts cancelled by OOMAPAS-Ímuris are not eligible to participate in the bidding process.

Qualified interested companies are hereby invited to submit technical and financial bids in Spanish in a sealed envelope, for a fixed-term, work-order-based contract to carry out the aforesaid services in relation to infrastructure project.

General descripción: Management, coordination and supervision services for construction of the wastewater collection system improvements in Ímuris, Sonora.

Pre-bid meeting: April 30, 2024 at 11:00 a.m. (local time).

Bid submission deadline: May 9, 2024, no later than 10:00 a.m. (local time).

The corresponding bid documents and terms of reference will only be published in Spanish and may be inspected and acquired free of charge (only) via Internet at <https://compranet.hacienda.gob.mx>. The documents may also be inspected as of the date of this publication and until **May 9, 2024**, Monday through Friday from 8:00 a.m. to 3:00 p.m. (local time), at the Ímuris City Council building located at Luis Donaldo Colosio 24, colonia Centro C.P. 84120, Ímuris, Sonora, Mexico, tel.: Switchboard 011 [52] (632) 326-0200 horas.

Bids may be presented in U.S. dollars or Mexican pesos. Monthly invoices will be paid in the currency indicated in the bid. For the purposes of bid evaluation only, the exchange rate published in the *Diario Oficial de la Federación* for the settling of obligations denominated in foreign currency payable in Mexico, will be used. The date used as the basis for the conversion will be six calendar days prior to the date for opening the bids.

No advance payment for these services will be provided.

The duration of this work is approximately 210 calendar days. The probable start-up and completion dates for the work are **May 30, 2024** and **December 26, 2024**, respectively.

Bid documents will be obtained via the Internet at <https://compranet.hacienda.gob.mx>; however, the general requirements that will be requested in the bid documents and that bidders must meet are as follows:

1. Brief description of the company, its organization and services.

2. Companies interested in providing the services must have at least five (5) years of experience in supervising construction works of a comparable complexity and similar or greater size.
3. Details concerning the experience required for the work advertised, gained over the last five years, including a brief description of the activities performed, amount contracted, duration of the work and the personnel who participated.
4. Contact name and phone number for at least three of those projects completed within the past five (5) years, as references.
5. Curriculum vitae (CV) of staff available to work on this project. Consideration will only be given to the CVs of those persons that have direct experience in water and wastewater infrastructure and mechanical, electrical and control works and who have the ability to work in Spanish.

Bidders are encouraged to visit and inspect the work sites and surrounding area on their own to obtain all the information that may be needed to prepare their bids and execute the service contract.

Any questions from potential bidders must be submitted in writing, no later than **April 29, 2024**, no later than 3:00 p.m. (local time) to the attention of the Director General of the Executing Agency indicated below. The responses to the questions will be provided in the minutes of the pre-bid meeting or a Clarification addendum to the procurement documents, as necessary, and will be published on the Internet at <https://compranet.hacienda.gob.mx>.

Bidders must submit separate technical and financial proposals in accordance with the instructions provided by the Executing Agency. Bidders must not include any type of pricing information in the technical proposal. Proposals must be valid for a period of ninety (90) days from the date of submission, during which the proposed price and personnel for the project shall not be changed.
